
*Page 25, Box # 22*

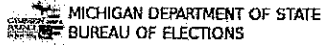
Please also note that some contributions were corrected to show that they were fundraiser contributions.




